Before being permitted to take the real estate salesperson's examination, it is necessary to complete a 40-hour accredited license training course in the principles of real estate. We are currently one of the few real estate training courses in West Michigan certified and licensed by the Michigan Department of Licensing and Regulatory Affairs statutory course requirements. (Permit #326)

The tuition paid by the student is totally refundable prior to the start of the class, provided that the textbook is returned in unused condition. After the start of class, fees are partially refundable. Classes consist of 10 sessions. A \$25 registration fee, \$50 textbook fee, and a pro-rated fee per session (\$19) will be charged and is not refundable. Cancellation of class must be in writing. All refunds should be returned within 30 days.

Payment may be done at the time of registering online via credit card, or may be paid at the time of class via check or money order. No cash accepted.
